

R E S O L U T I O N    N O.    3086

AND ORDER CANVASSING ELECTION, DECLARING ESTABLISHMENT  
IN SAN MATEO COUNTY OF THE PENINSULA HOSPITAL  
DISTRICT, AND DEFINING THE BOUNDARIES  
OF SAID DISTRICT.

RESOLVED, by the Board of Supervisors of the County  
of San Mateo, California, that

WHEREAS, a petition for the organization of a local  
hospital district designated as PENINSULA HOSPITAL DISTRICT,  
in accordance with the provisions of Chapter 932 of Statutes  
of 1945 of the State of California was presented to and filed  
with this Board of Supervisors of San Mateo County at a  
regular meeting thereof on August 19, 1947, which petition  
has been found by the Clerk of this Board to be signed by  
registered voters residing within the boundaries of said pro-  
posed district equal in number to at least fifteen per cent  
of the number of votes cast in said proposed district for the  
office of Governor of the State of California at the last pre-  
ceding election at which a governor of this State was elected,  
to wit: the election of November, 1946; and

WHEREAS, this Board of Supervisors set the 7th day  
of October, 1947, at 11 o'clock A.M., at the Supervisors'  
Chambers in the County Court House at Broadway and Hamilton  
Street in the City of Redwood City, said county and state as  
the time and place for final hearing on said petition; and at  
that time less than a majority of the registered voters in  
said proposed district protested against the formation of  
said district; and

WHEREAS, said Board of Supervisors did on said  
October 7, 1947, adopt its Resolution No. 3017 determining

that the project for the organization of a proposed local hospital district to be known as PENINSULA HOSPITAL DISTRICT is feasible, economically sound and for the public interest; and

WHEREAS, said Board of Supervisors did by said Resolution No. 3017, call and order to be held a Special Election to be held in the area of said proposed local hospital district on Tuesday, November 25, 1947, to determine whether such proposed district should be formed into a Local Hospital District and did therein define the boundaries of said proposed district; and

WHEREAS, notice of said election has been duly given, and said election has been duly held, canvassed and declared in accordance with law.

NOW, THEREFORE, IT IS RESOLVED, FOUND AND DETERMINED as follows:

1. That said election was held and conducted, canvassed and declared in the manner prescribed by "The District Organization Act of 1933" and the question submitted on the ballots at said election was stated in the following manner, to wit:

Shall the proposed Hospital District be formed in San Mateo County, State of California, as designated by Resolution No. 3017 of the Board of Supervisors of said County adopted October 7, 1947, and designated as "PENINSULA HOSPITAL DISTRICT",

LOCAL HOSPITAL DISTRICT "YES" ( )

LOCAL HOSPITAL DISTRICT "NO" ( )

2. That the number of votes cast at said election at the polling places provided therefore, was 11,810; and the number of said votes cast at said election in favor of the formation of said Local Hospital District was 11,331, and the number of said votes cast at said election against the formation of said Local Hospital District was 454.

That the total number of absentee ballots applied for and cast at said election was 11; and the

number of said absentee ballots cast in favor of the formation of said Local Hospital District was 11, and the number of said absentee ballots cast against the formation of said Local Hospital District was none.

3. That the total number of votes cast at said election was 11,810, and 11,331 number of said votes were in favor of forming said District, and 464 number of said votes were against the forming of said District, and a majority of all votes cast were in favor of forming said District.

4. That a Local Hospital District of the name of PENINSULA HOSPITAL DISTRICT has been duly established, with the boundaries stated in the order calling said election, which boundaries are particularly set forth as follows:

All that territory situate, lying and being in the County of San Mateo, State of California, and particularly bounded and described as follows, to wit:

Beginning at the intersection of the westerly line of Section 24, Township 4 South, Range 6 West, with the southerly line of the San Pedro Rancho; running thence northeasterly along the said line of said Rancho to its intersection with the easterly line of the Jersey Farm Company 1029.27 acre tract; thence northerly along said easterly line and its production northerly to its intersection with the westerly line of the Buri Buri Rancho; thence southerly along said westerly line to the southerly line of the property formerly known as the Ashton Tract; thence easterly and northerly along said Ashton Tract to the most southerly corner of the D. O. Mills 786.55 acre tract; thence northerly along said 786.55 acre tract to the northwesterly corner thereof; thence northwesterly to the most southerly corner of California Golf Club Underwriters Corporation 374.38 acre tract, thence southeasterly and northeasterly along the southerly line of the Flood Realty Company 413.09 acre tract and its extension northeasterly to the northeasterly line of the State Highway which is also the City Limits of South San Francisco; thence in a general easterly direction following the City Limits of South San Francisco to the northeast corner of Section 34, Township 3 South, Range 4 West; thence North to the northeasterly corner of Section 27, Township 3 South, Range 4 West; thence East to the East boundary of the County of San Mateo; thence southeasterly along the County line to the line dividing Section 15 and 22, T4S R3W; thence West to the northwest corner of Section 22; thence South one mile; thence West  $2\frac{1}{2}$  miles; thence North  $\frac{1}{2}$  mile to the center of Section 19; thence West  $\frac{1}{2}$  mile, thence South  $\frac{1}{2}$  mile, thence West one mile, thence South one mile, thence West  $1\frac{1}{2}$  miles to the quarter corner on the northerly line of Section 34; thence south along the center line of said Section 34 to the quarter corner on the south boundary of said Section 34; thence southwesterly in a direct line to the southeast corner of the Mary B. McClellan 30.82 acre tract, said point being in the easterly boundary of the City of San Mateo; thence southeasterly, southwesterly and northwesterly along said city boundary line to the centerline of Laurel

Creek; said point being in the northeast boundary of the Carrie A. Jury and Burleigh C. Murray 532.67 acre tract; thence northwesterly along said northeasterly line to its intersection with the westerly line of Beresford Park; thence northwesterly along the westerly line of Beresford Park to the southerly line of the Dinnegan & O'Brien 113.81 acre tract; thence westerly along said 113.81 acre tract and along the southerly boundary of the Beresford Country Club 62.68 acre tract to the easterly boundary of the lands of City and County of San Francisco; thence southeasterly and southwesterly along the property of the City and County of San Francisco and the County Poor Farm and continuing southeasterly along Spring Valley Water Company 1161.78 acre tract to the southeasterly corner thereof; thence southwesterly along the southerly line of said tract to the southwesterly line of the Rancho de Las Pulgas, thence southeasterly along the said Rancho line to the line dividing the 449.19 acre tract and the 659.80 acre tract, both of the City and County of San Francisco, thence southwesterly along said dividing line to its intersection with the southwesterly line of the Rancho Canada de Raymundo, thence northwesterly along said southwesterly line of the Rancho Canada de Raymundo to its intersection with the Skyline Boulevard, thence northerly along the center of the Skyline Boulevard to the north line of Section 24, T5S R5W, thence East to the southwest corner of the southeast quarter of the northwest quarter of Section 13, T5S R5W, thence north  $\frac{1}{4}$  mile; thence west  $\frac{1}{2}$  mile; thence north  $\frac{1}{4}$  mile; thence west  $\frac{1}{4}$  mile; thence north  $\frac{3}{4}$  mile; thence west  $\frac{1}{4}$  mile; thence north  $\frac{1}{2}$  mile; thence west  $\frac{1}{4}$  mile; thence north  $\frac{1}{2}$  mile; thence west  $\frac{1}{4}$  mile; thence north  $\frac{1}{4}$  mile; thence west  $\frac{1}{4}$  mile; thence north  $\frac{1}{2}$  mile to the line dividing Township 4 South, Range 5 West and Township 5 South, Range 5 West; thence westerly along said line to the line dividing the properties of Spring Valley Water Company and C. A. Johnson; thence northwesterly along said line dividing Spring Valley Water Company and land of Johnson to the north and south center line of Section 30, Township 4 South, Range 5 West; thence northerly to the center of Section 30, Township 4 South, Range 5 West; thence West  $\frac{1}{2}$  mile; thence North  $\frac{3}{4}$  mile; thence West  $\frac{1}{4}$  mile; thence North  $\frac{1}{4}$  mile; thence West  $\frac{1}{4}$  mile; thence North  $\frac{1}{4}$  mile; thence West  $\frac{1}{2}$  mile to the westerly line of Section 24; thence northerly along said line to the point of beginning.

5. That this order shall be entered in the minutes of the Board of Supervisors, and the clerk of said Board shall file for record a certified copy hereof in the office of the County Recorder of San Mateo County and file a certified copy hereof with the Secretary of State of the State of California.

6. That the County Clerk file with the State Board of Equalization and with the County Assessor of San Mateo County, prior to February 1, 1948, a statement of the creation of the Peninsula Hospital District, setting forth therein the legal description of the boundaries of the District so created, together with a map or plat indicating such boundaries.
